This information can include: Driver's license number, Social Security number, and taxpayer identification number Name, date of birth, address, phone number(s), and email address(es) Account information (including other institutions); assets and liabilities; income and expenses; investment activity; and investment experience and goals We also collect the following information from other sources: Custody, brokerage and advisory agreements Other advisory agreements and legal documents Transactional information with us or others Account applications and forms Investment questionnaires and suitability documents Other information needed to service account All financial companies need to share customers' personal information to run their everyday How? business. How does AdviceOne protect my personal information?	To safeguard your personal information from unauthorized access and use we maintain physical, procedural and electronic security measures. These include such safeguards as secure passwords, encrypted file storage and a secure office environment. Our technology vendors provide security and access control over personal information and have policies over the transmission of data. Our associates are trained on their responsibilities to protect Clients' personal information. We require third parties that assist in providing our services to you to protect the personal information they receive from us.		
How does AdviceOne collect my personal information? Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
